Location & Description

Harlow is a major urban centre with a resident population of circa 93,000 people. The town lies just off the M11 providing excellent communication links to the M25, London, Stansted Airport via the A120, and to the Midlands via the A14 at Cambridge.

Merring Way forms part of an established industrial area in Harlow, other major occupiers nearby including Unitrunk, Crosby Electrical Services Limited and GXO. The property forms part of a modern development of terraced industrial units built approximately 20 years ago and is of steel portal frame construction incorporating brick / corrugated steel cladding beneath a pitched insulated roof incorporating translucent roof panels.

The property benefits from all mains services, sealed concrete floor, eaves height of 6.1m (7.5m to the pitch), ground / first floor glazing to the front elevation, three loading doors (one at half height), sodium lighting, ground and first floor offices, kitchen and wc facilities.

Externally there is forecourt parking and loading off the shared service road.




