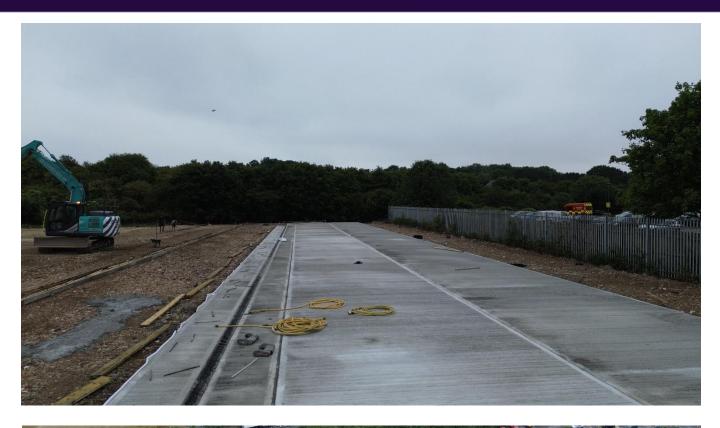
Access is controlled via a 15-metre electric sliding entrance gate, offering secure and convenient entry for vehicles and personnel.
